We have an AB12 eligible youth placed with relatives but lives in a separate residence on the property who purchases and prepares separately. Can the youth apply for CF?

10. REQUESTOR'S PROPOSED ANSWER:

Yes, if the relative is not acting in a parental capacity and the youth is handling their own affairs.

11. STATE POLICY RESPONSE (CFPB USE ONLY):

No. According to our phone conversation on 2-01-13, you indicated that this is an approved foster care placement with the relatives receiving AFDC-FC payments on behalf of the non-minor dependent. Since the court approved placement is in the home of a relative, per MPP 63-402.322 (b), the youth is considered a boarder and may participate in the CalFresh Program only at the household's request and not as a separate household.
