Is the excluded spouse's Social Security disability income counted in the CalFresh benefits calculation?</p> <p>I ask this because 63-503.443 provides that the eligibility and monthly allotment of any remaining household members of a household containing individuals excluded for being an SSI/SSP recipient shall be determined in accordance with the requirements for Nonhousehold members as specified in Section 63-503.45, and 63-503.45 provides the income and resources of nonhousehold members and the excluded household members specified in Sections 63-402.226 (SSI/SSP recipients), shall not be considered available to the household, but 63-402.21 provides for purposes of defining a household, the following individual shall not be included as a member of the household unless included as a household member as specified in 63-402.14 which provides separate status shall not be granted to: .143 An individual living with the household who is a spouse of a member of the household.</p>
