9. QUESTION: (INCLUDE SCENARIO IF NEEDED FOR CLARITY):

Scenario:

Elderly and/or disabled HH applies for CalFresh. The HH's income is over 130% FPL, so they are not BBCE. Since the HH is elderly, we do not apply the 130% gross income test. The HH is under the net income limit, and is therefore income eligible to CalFresh. Since they are not BBCE, do we next need to apply the resource regulations found in 63-501 to determine resource eligibility for CalFresh?

10. REQUESTOR'S PROPOSED ANSWER:

Yes, since the HH is not BBCE and not subject to the 130% gross income test for CalFresh, we must determine if there is resource eligibility based on 63-501.

11. STATE POLICY RESPONSE (CFPB USE ONLY):

In CA, 130% of the FPL is currently the established maximum gross income for all households (HH) to have BBCE or MCE conferred. ACL 12-62 does not change the standard eligibility requirements, including passing a resource test per 63-501, that an elderly and/or disabled HH must meet to be CalFresh eligible when they have not been conferred BBCE or MCE.
