In the clarification of the situation "break in aid:

A CF household became Inactive 05/01/2012. The clients come in to re-apply in February 2013

During the interview process the client refers to income made in 01/2012. A task is set to verify income in 2012.

The case is granted and 2 months later an over-issuance is calculated in the amount of \$110.00 for 02/12 - 03/12.

Shall the Over-issuance be established and collected, because the case is active at the time of calculation, even though there was a break in aid between the month of OP and the date of calculation?

10. REQUESTOR'S PROPOSED ANSWER:

Since the CalFresh Household is Active at the time of discovery the Overissuance shall be established and collected.

11. STATE POLICY RESPONSE (CFPB USE ONLY):

CDSS agrees with the proposed answer. An overissuance claim of \$110 shall be established and collected by the county since it was discovered while the CalFresh case was active.
