Effective May 2011, the Department of Health Care Services (DHCS) implemented a new statewide program to identify income discrepancies using the the PARIS (Public Assistance Reporting Information System) match. Per ACWDL 11-14, the information received by the PARIS is to be treated as verified federal income information for Medi-Cal.

Will CWDs use the PARIS match as information verified through a computer matching program under Quarterly Reporting/Prospective Budgeting (QR/PB)?

Will CWDs use the PARIS match as Verified Upon Receipt (VUR) under Semi-Annual Reporting (SAR)?

10. REQUESTOR'S PROPOSED ANSWER:
Under QR/PB, CalFresh will use the PARIS match as information verified through a computer matching program per 63-300.23.
Under SAR, CalFresh will use the PARIS match as Verified Upon Receipt per ACL 13-17.
