The investigation did not specifically state that our client and her boyfriend purchased and prepared together.

Question: Are we to assume that because our client lives with her boyfriend and they eat together that they purchase and prepare together? Would overpayments be calculated on this case?

10. REQUESTOR'S PROPOSED ANSWER:

63.402.213 Other individuals who share living quarters with the household but who do not customarily purchase food and prepare meals with the household.

Unless it can be confirmed with certainty that the client and her boyfriend purchase food and prepare meals together, we can not calculate claims on this case.
