9. QUESTION: (INCLUDE SCENARIO IF NEEDED FOR CLARITY):
 Can a customer be held responsible (overissuance processed) for failing to report mandatory information if their report form doesn't ask them the question?

For example, a customer marries their live-in boyfriend prior to the SAR 7 submit month but they didn't purchase & prepare together previously so he wasn't on the CalFresh case. The SAR 7 doesn't ask this question for CalFresh, only if someone moved in or out of the home. So if the marriage is later discovered at re-evaluation and his income at the time would have made the household ineligible would the county be correct in writing up an overissuance even though the customer reported appropriately based on the wording of the SAR 7?

10. REQUESTOR'S PROPOSED ANSWER:
 No, the recipient is required to report changes in household composition at SAR (63-508.321) but since the report form only asks them to report someone moving in or out of the home, an overissuance would not be appropriate in this case.
