Why are questions #4 and #13 on the SAR 7 for CalWORKs only when they should be answered by NACF recipients who are not receiving CalWORKS?
 #4 - NACF households are not required to report a change in fleeing felon status or probation/parole violations mid-period. If an individual had a change in fleeing felon status or probation/parole violations during the semi-annual period, it would be reported on the next SAR 7 or recertification and the CWD would discontinue the individual at the end of the report month after 10-day notice can be provided.
 #13 - NACF recipients who are not receiving CalWORKS also need to report any other changes that happened since they last reported, but they are not asked to report other changes for CalFresh.

10. REQUESTOR'S PROPOSED ANSWER:

Questions #4 and #13 on SAR 7 should be updated to show that CalFresh only recipients also need to report these changes.

11. STATE POLICY RESPONSE (CFPB USE ONLY):

The state does not agree with requesters proposed answer, due to the fact that information collected in questions #4 and #13 are NOT required for CalFresh only recipients. Federal regulations 7 CFR 273.12(a) (5) specifies what information under SAR is required for CalFresh for which items under question #4 and #13 are not mentioned.
