1. Case is PA and they are SAR Reporting. Household becomes homeless in the process. Should their reporting for CalFresh change from SAR to Change Reporting now that they are homeless or will their reporting requirement remain SAR to align with CalWORKs.
 2. If the PA household is AR/CO and has no cycle attached and the household becomes homeless or Elderly/disabled do they become Change Reporting for CalFresh?

In both situation, CalWIN is currently changing the combo case households Change Reporting for the CF and SAR for the CW based on these two situations.. ACL 13-17 states that AR/CO cases which are currently change only cases for the CF program, will transition to SAR effective October 1, 2013.

10. REQUESTOR'S PROPOSED ANSWER:

For both situations, the CalFresh portion should be Change Reporting and not SAR if the HH's for combo cases become homeless or meet the Elderly/Disabled criteria and are subject to change Reporting requirements.
