Customer asked had his SSI/SSP benefits discontinued so he could get CalFresh.

10. REQUESTOR'S PROPOSED ANSWER:

Yes he would be eligible to CalFresh benefits since he is no longer receiving SSI/SSP. Regulation 63-402.266 states that a person:
 "Once receiving SSI/SSP benefits, the person will remain ineligible for food stamp benefits until actually terminated from the SSI/SSP Program; periods of nonreceipt or suspension of SSI/SSP payments do not restore food stamp eligibility."
 The regulation does not specify that the person has to be terminated from SSI/SSP by SSA only that they be terminated.

11. STATE POLICY RESPONSE (CFPB USE ONLY):

If the recipient has been "suspended", he must wait until he has been "terminated" from the SSI/SSP program. Per MPP 63-402.266, the recipient would be eligible to receive CalFresh as long as he has been "terminated" from the SSI/SSP Program, as long as he meets all the other conditions of eligibility.
