9. QUESTION: (INCLUDE SCENARIO IF NEEDED FOR CLARITY):

1 Is a Household (HH) entitled to Seasonal Farmworker status if the season ends the month prior to application? 63-102 states, "Seasonal Farmworker" means a non-migrating individual who is employed seasonally in an agricultural production activity during the certification period.

#2 Is the HH still considered Change Reporting when another adult in the HH is employed full time in another line of work. Example: HH applies in July 2015. Mom/Dad and 3 children. Dad works as taxi driver/Mom gets UIB. However Mom reports she stopped working seasonal farm labor June 2015, with last pay in June 2015.

63-102 states, "A seasonal farmworker HH is a HH in which any member is a seasonal farmworker. Seasonal Farmworker HHs are granted change reporting status." This could potentially cause the HH to report more frequently and provide verification more often than a regular SAR HH. Elderly and Disabled HHs are now considered SAR if the HH has earned income.

10. REQUESTOR'S PROPOSED ANSWER:

Response # 1 The HH may not be entitled to "Change Reporting status as the season ended prior to the date of application.

Response # 2 The HH should be considered SAR due to the full-time employment of another adult in the HH.

11. STATE POLICY RESPONSE (CFPB USE ONLY):

#1. If the farmworker will be working again when the season begins again they would still be considered a seasonal farmworker and therefore would be eligible for seasonal farmworker status. Unless the farmworker has specifically stated that they will not be working in the following year, the household would be considered change reporting.

#2. Per MPP 63-102: "A seasonal farmworker HH is a HH in which any member is a seasonal farmworker." If the mother has stated that she still intends to be a seasonal farmworker, the household would still be considered change reporting.
