Are higher education students who reside in a dormitory and have a meal plan through the university that provides more than 50% of their meals eligible for CalFresh or are they excluded under 63-402.4 as a resident of an institution?

10. REQUESTOR'S PROPOSED ANSWER:

These persons should be ineligible to CalFresh benefits.

I cannot find anything in CDSS material with an answer to this question, however I have found material from Massachusetts, Oregon and West Virginia which states that these persons should be considered residents of an institution.

11. STATE POLICY RESPONSE (CFPB USE ONLY):

A student who resides in a school dormitory and receives the majority of his meals from the institution's meal plan is ineligible for CalFresh consistent with regulations at Manual of Policies and Procedures (MPP) Section 63-402.4. Students who purchase and prepare their own meals, or who reside in school dormitories with optional meal plans and do not receive the majority of their meals from the institution may be eligible for CalFresh.
