## 10. REQUESTOR'S PROPOSED ANSWER:

Only \$2,000.00, of gambling Per Capita Income is exempt per year as set forth in the regulations.

Please note, that although MPP 44-111.1 is a CalWORKs regulation it is referenced in MPP 63-502.2(q) as a source of exempt income.
