Since resource value is waived with MCE/BBCE for CalFresh, is the county allowed to ask for proof of property held in a living trust in order to verify it is not income producing. What verification can the county require the client to provide?

10. REQUESTOR'S PROPOSED ANSWER:

Answer #1: Client signs the Statement of Facts indicating reported income. No other verification is required.

Answer #2: The client either needs to provide verification of the properties held in the trust or a signed Declaration of Facts indicating all properties held in trust. If any property listed is potentially income producing, the client would be required to provide any applicable verification of income.

11. STATE POLICY RESPONSE (CFPB USE ONLY):

Although the value of resources are exempt from consideration for households that have been conferred MCE/BBCE, income produced by such resources is not exempt. Therefore, as stated in MPP 63-300 and ACIN I-45-11 all income must be evaluated in the determination of benefit amount. The criteria for verification are cited in the referenced regulations and ACIN.
